Iri teka rigamije kwimurira muri RIB bamwe mu bakozi n'imwe mu mitungo byari muri Polisi y'u Rwanda birebana n'Ubugenzacyaha.

Ingingo ya 2: Iyimurwa ry'abakozi

Bamwe mu bapolisi babarizwaga muri Polisi y'u Rwanda bakoraga imirimo ifite aho ihuriye n'Ubugenzacyaha kimwe n'abakozi bunganira bimuriwe muri RIB.

Abakozi bimuriwe muri RIB bari ku rutonde rushyizwe ku mugereka wa I w'iri teka.

Ishyirwa mu nzego no mu myanya yimirimo ku bakozi bimuwe bikorwa hakurikijwe ibiteganywa n'itegeko rishyiraho RIB.

Ingingo ya 3: Iyimurwa ry'umutungo

Imwe mu mitungo yimukanwa, yacungwaga na Polisi y'u Rwanda yimuriwe muri RIB.

Urutonde rw'imitungo yimuriwe muri RIB ruri ku mugereka wa II w'iri teka.

Article One: Purpose of this Order

This Order determines transfer to RIB some of the staff and property of Rwanda National Police in connection with judicial police.

Article 2: Transfer of staff

Some of the staff of Rwanda National Police whose activities are in connection with judicial police and some of support staff are transferred to RIB.

The personnel transferred to RIB are on the list of the annex I of this Order.

The appointment of rank and post of the transferred staff are in accordance of law establishing RIB.

Article 3: Transfer of property

Some of Movable assets, within the competence of Rwanda National Police are transferred to RIB.

The list of property transferred to RIB are in Annex II of this Order.

Article premier: Objet du présent arrêté

Le présent arrêté détermine les modalités de transfert à RIB certains membres du personnel et certains éléments du patrimoine de la Police Nationale du Rwanda en rapport avec la police judiciaire.

Article 2: Transfert du personnel

Certains membres du personnel de la Police Nationale du Rwanda dont les activités sont liées à la police judiciaire et certains membres du personnel de soutien sont transférés à RIB.

Le personnel transféré à RIB sont sur la liste de l'annexe I du présent arrêté.

Le placement au grade ainsi que l'affectation au poste de travail pour le personnel transféré se fait conformément à la loi portant création de RIB.

Article 3: Transfert du patrimoine

Certains des biens meubles qui relevaient de la compétence de la Police Nationale du Rwanda sont transférés au sein de RIB.

La liste du patrimoine transféré à RIB est en annexe II du présent arrêté.

Article 4: Authorities responsible for the implementation of this Order

The Minister of Justice/Attorney General, the Minister of Infrastructure and the Minister of Finance and Economic Planning are entrusted with the implementation of this Order.

Article 5: Repealing provision

All prior provisions contrary to this Order are repealed.

Article 6: Commencement

This Order comes into force on the date of its publication in the Official Gazette of the Republic of Rwanda.
